**AN ORDINANCE TO ADOPT THE BUDGET STATEMENT TO BE
TERMED THE ANNUAL APPROPRIATION BILL; TO APPROPRIATE
SUMS FOR NECESSARY EXPENSE AND LIABILITIES: TO PROVIDE
FOR AN EFFECTIVE DATE,**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF ALMA,
NEBRASKA:**

Section 1. That after complying with all procedures required by law, the budget presented and set forth in the budget statement is hereby approved as the Annual Appropriation Bill for the fiscal year beginning October 1, 2009 through September 20, 2010. All sums of money contained in the budget statement are hereby appropriated for the necessary expenses and liabilities of the City of Alma. A copy of the budget document shall be forwarded as provided by law to the Auditor of Public Accounts, State Capitol, Lincoln, Nebraska, and the County Clerk of Harlan County, Nebraska, for use by the levying authority.

Section 2. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
