MINUTE RECORD FOR CITY OF ALMA REGULAR CITY COUNCIL MEETING November 2, 2022

A regular meeting of the City Council of the City of Alma, Nebraska was held at City Hall on Wednesday, November 2, 2022, at 5:30 p.m.

Present were Council Members: Dyann Collins, Tom Moulton, Larry Casper, Chris Tripe and Mayor Hal Haeker. Absent: None. Administrator Lorri Bantam, City Treasurer CeeAnn Affolter, City Clerk Dawn McNulty, City Utility Superintendent Russ Pfeil, and City Attorney Doug Walker were also in attendance. Notification of this meeting and the agenda was given in advance by posting, a designated method for giving notice. Advance notice of the meeting and the agenda was given to the mayor and all members of the City Council. All proceedings hereinafter were taken while the convened meeting was open to the attendance of the public.

Mayor Haeker advised the public of the Open Meetings Act posted on the east wall of the meeting room, and then proceeded to call the regular meeting of November 2, 2022, at 5:30 p.m. and the following business was transacted:

Roll call: Tom Moulton-present, Dyann Collins-present, Larry Casper-present, Chris Tripe-present, and Mayor Haeker-present. Motion made by Casper, second by Collins to determine this meeting as previously publicized, duly convened and in open session. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Collins, Casper, Tripe, and Moulton. Voting no: None. Motion carried.

Mayor Haeker opened the floor to approve the minutes of the October 19, 2022, regular council meeting. Motion made by Tripe, second by Moulton to approve the minutes of the October 19, 2022, regular council meeting. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Moulton, Casper, Tripe and Collins. Voting no: None. Motion carried.

Mayor Haeker opened the floor to discuss the claims and invoices for October 20, 2022, through November 2, 2022, for a total of \$49,163.42. Motion made by Moulton, second by Casper to approve the claims. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Collins, Tripe, Casper, and Moulton. Voting no: None. Motion carried.

Mayor Haeker opened the floor to discuss the Treasurer's report. Motion by Tripe, second by Moulton to accept the Treasurer's report as presented. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Collins, Casper, Tripe, and Moulton. Voting no: None. Motion carried.

Mayor Haeker opened the floor to discuss the Western Sky updates. Rick Calkins was in attendance and shared that half of the lots are sold and were ahead of projection. Mr. Calkins felt city needs to be looking ahead because the few remaining lots could be sold in 2-3 years. He stated there were some developers planning to build a duplex and were ready to finalize but decided to move to Holdrege. He stated the Covenants needed to be amended to allow multi-family units as it is only single family currently, and the developers were offered free lots in Holdrege. Alma needs to be looking at giving developers incentives to build here. He feels that commercial development is stifled, and we do not have much to offer them. He recommended that the Council needs to be looking at the final plat on the second phase so that we can look at getting sewer and water in. There is no TIF Program for phase 2.

AN ORDINANCE OF THE CITY OF ALMA, NEBRASKA TO AMEND MUNICIPAL CODE SECTION 32.01 LIBRARY BOARD; TO REPEAL ALL ORDINANCES OF PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; AND TO PROVIDE FOR AN EFFECTIVE DATE.
