**Did vou know** ...... Firewood is available for cutting on the walking trail and at the compost site for a \$20.00 annual fee. The wood cut must be used to heat your home and may not be re-sold. You can fill out a permit at the City office during regular business hours. You would be allowed to cut downed and dead trees along the walking path (approximately 15 feet on either side of the path) or at the compost site. You would need to inform the City of where you plan to cut. Any wood beyond that limit is on the Army Corps ground and requires an additional permit. If any wood is taken out of a pile, whatever is not taken with you must be put back in the pile. The City does ask that you clean up after yourself. Firewood must be removed from the property the same day it is cut, no guarantee it will not be removed by others. Firewood may be taken from the Compost site during regular compost hours, unless permit holder has rented an annual compost key separate from this permit, or a daily key from the City Office. The firewood cut must be for the permit holder's own use. The selling or bartering of firewood cut from these locations is prohibited.

# Dog Tags are Available Now

The City reminds you to license your dog by purchasing a 2024 tag. The cost is \$7.25 for a male or spayed

female and \$12.50 for an un-spayed female. Pursuant to City Code 90.20 to 90.22, any dog over the age of 6 months shall be licensed within 30 days of acquisition and annually by the 1st day of January of each year. Said tax is considered delinquent after March 10th. To license your dog, stop by the City Office and be sure to bring your certificate proving your dog has had their rabies shot effective for the licensing year.



### <u>COMPOST WINTER HOURS</u>

Wednesday & Saturday 9:00 am to 3:30 Compost winter hours go in to effect October through March If you need services outside of these hours, you can rent a compost key for \$5.00 and a \$20.00 deposit from the city office.



NEED TO HOST AN EVENT? - CONSIDER THE JOHNSON CENTER OR THE CITY AUDITORIUM!!!

The facilities have enough tables and chairs in each building to fill the large room. Each facility has a large room along with a kitchen and separate bathrooms. For most events, the rental fee for the Auditorium is only \$35 a day and the Johnson Center is \$75 per day. A security deposit is required. It is so convenient to host family gatherings or special events at either facility. The City is also offering special deals!!! Pay for 2 days rental and get the third day free! Example: Nov 1, 2 and the 3rd is free. Also, if you host an event on a Tuesday or Wednesday, the rental fee is half price!

City Council Meetings are the 1st and 3rd Wednesday of each month at 5:30 pm at City Hall. These meetings are open to the public and the public is encouraged to attend. Agendas are posted each Friday prior to the meeting at City Hall, Hogeland's Market, Alma Post Office, and Trustworthy Hardware. If there is an agenda item of particular interest to you, the Mayor, City Council and City Staff encourage you to attend the meeting.

## **Snow Removal - It's inevitable! Snow will be falling in the next few months!!! Please note the following:** The City of Alma would like to express its appreciation for its citizens who understand the importance of keeping their sidewalks free of snow and ice. According to City Ordinance 96.20, it shall be unlawful for the occupant of any lot(s) or the owner of any vacant lot(s) within the corporate limits to allow snow, sleet, mud, ice or other substance to accumulate or remain on said sidewalks.

Residential sidewalks shall be cleaned within 24 hours after the snow storm. All sidewalks within the business district shall be cleaned within 5 hours after the cessation of the storm, unless the storm or fall of snow shall have taken place during the night, in which case the sidewalk shall be cleaned before 9:00 a.m. the following day.

Take special care and use common courtesy when clearing your driveway. Ask for your neighbor's permission before you pile your snow on their **terrace (area between curb line and property line)** or yard. Rocks and other debris can collect on your driveway and by piling your snow on your neighbor's property you are depositing those items in their yard to be mowed over in the spring.

**EMERGENCY SNOW ROUTE** - Typically when it snows the City employees have two trucks with plows running to clear the streets. The streets cleaned first are **Main**, **South**, and **Third** running east and west. Running north and south are **James**, **Division**, **Lincoln**, **Kennedy** and **Brown** Avenue - north of the highway. By cleaning these streets first, the majority of Alma citizens will have only one or two streets of snow to drive through to get to a cleared street.



The City of Alma has a **Fair Housing Ordinance** that is designed to prohibit discrimination in housing. It is the declared policy of the City of Alma that all persons shall have an equal opportunity for housing, regardless of sex, race, color, handicap, religion, national origin, sex or marital status of the person maintaining a household, lawful source of income, age or ancestry. The ordinance is deemed an exercise of the police powers of the City for the protection of the welfare, health, peace, dignity and human rights of the people of this City. Do you like to walk? Want to try a different path? Have you tried "**Peckerneck Trail**"? It was designed for horseback riders and hikers. It's 12 miles of trails. The trail starts at Alma Vista. Where is Alma Vista you might ask? It is about one mile south of Alma on the east side of Highway 183, just after you cross the bridge (it is a parking area). The first loop takes about one and a half hours to ride or hike and is well established. There is a second loop which will take about 2 more hours. The entire trail takes about 6 hours. **TRASH CONTAINERS & COLLECTION**—All trash is to be bagged and tied. The trash toter is to be placed in the proper street facing direction for pick up. This is marked on the toter. Toters must be placed on the street curb the night before pickup or before 7:00 am the morning of pickup. Grass clippings, tree branches and other yard waste is not allowed. There is a compost site south of town where they may be taken. Please see our website for a listing of other unacceptable items—www.almacity.com, Resident's tab, Sanitation/Solid Waste Department.

**Compost Site**—Hours of Operation changed on October 1st. It is open on Wednesday 9 am to 3:30 pm and Saturday, 9 am to 3:30 pm. If you need to use the compost site outside of these hours, you can rent a key from the city office for a \$5.00 fee and a \$20.00 deposit.

# ALWAYS REVIEW EACH AND EVERY UTILITY BILL

It is a very good idea to review each bill and reference back to the previous bill. Is there a significant difference? We have had customers discover they have a water leak because their bill was huge. If they had only reviewed the prior bill, they may have avoided a huge water bill! Leaky toilets and broken water lines can be costly on your bill!

### **DOGS RUNNING AT LARGE**

Per City Code 90.26—Any dog found off the premise of the owner, and not under control of the owner or a responsible person, either by leash, cord, chain, wire, rope, cage or other suitable means of physical restraint may be taken up and impounded. If the police cannot reasonably do so, they may kill on sight any dog found to be running at large.

# **GAS PIPELINE SAFETY**

As one of the thousands of people who live or work near pipelines, you can help keep it safe and reliable by doing the following:

A) notify us with your intention to dig;D) take appropriate steps if you notice a leak;

B) identify our pipelines;E) immediately report a leak

C) recognize a leak;

The City of Alma cares about your safety. Our employees are thoroughly trained to operate and maintain the system safely. We want you to be aware of our pipelines. We ask for your help in preventing accidental damage to pipelines. The City of Alma supports the Nation's Homeland Security efforts and the City of Alma encourages you to immediately notify and report any suspicious persons and/or activities near the pipeline to your local law enforcement authorities by calling 911.

#### A) NOTIFY US WITH YOUR INTENTION TO DIG - CALL 811-"diggers hotline"

We need your help in preventing pipeline emergencies. The number one cause of pipeline leaks is damage from earth-moving and construction equipment and tools owned by parties other than the pipeline company. If you plan to dig or do any type of excavation or construction work, call **Diggers Hotline at 811**. Call at least 48 hours (excluding weekends and holidays) before you:

Excavate	Install drain tile	Repair or rebuild roads or driveways	
Grade	Blast for clearing	Build homes or additions	
Auger	Dig postholes	Install water lines, sewer lines	
Bore	Cut or deepen ditches	septic systems, or drains	
Tunnel	Install swimming pools	Install telephone, TV or power, cables	
Dredge	Plant trees or shrubs		

#### **B) IDENTIFY OUR PIPELINES -HOW TO IDENTIFY WHERE THE PIPELINE IS LOCATED**

Since pipelines are buried underground, line markers are used to indicate the approximate - *not exact* - location of the pipeline. Line markers can be found where the pipeline intersects a street, highway, or railroad. However, they cannot be relied upon to indicate the exact position of the pipeline. The pipeline may not follow a straight course between markers, which provide no information on the depth or number of pipelines in the vicinity. Don't try to guess the pipeline's location or route by the marker's placement. Call Diggers Hotline at **811**.

#### **C) RECOGNIZE A LEAK**

HOW TO RECOGNIZE A PIPELINE LEAK WHEN NEAR A PIPELINE RIGHT OF WAY. <u>LOOK FOR</u>: Fire or explosion near pipeline, a white cloud or fog, dying plants amid healthy ones, unusual blowing of dirt or dust, persistent bubbles in water, or pool of liquids, possibly bubbling. <u>LISTEN FOR</u>: Hissing or roaring sound. <u>SMELL FOR</u>: A pungent odor, sometimes like rotten eggs.

Immediately leave the area - on foot - in an upwind direction.	Avoid making contact with es- caping liquids or vapors.	Warn others to stay away from
<b>DO NOT</b> drive into an area in which you encounter a leak or vapor cloud		<b>DO NOT</b> try to operate any pipeline valves yourself

**DO NOT** light a match, start an engine or automobile, use a telephone, or switch on/off an electric light or appliance.

#### D) TAKE APPROPRIATE ACTIONS IF YOU NOTICE A LEAK- WHAT TO DO?

#### E) IMMEDIATELY REPORT A LEAK- WHO TO CALL?

From a distant phone, call the City of Alma (308-928-2242) or the On-Call phone if after hours (308-920-1047) OR call 911 or your local fire, police or sheriff's office. DO NOT use a cell phone while near the suspected emergency area.
